It was moved by Dr. Roark and seconded by Mr. Cordova that the Board authorize the Board President to execute and deliver, on behalf of the District, a written consent to the assignment by Access Administrators, Inc., of its rights and obligations under the Earnest Money Contract with the District for the purchase of the Education Center-Downtown/Blue Flame Building and parking garage to El Paso Renaissance–Blue Flame, LP, a Texas limited partnership, conditioned upon the execution and delivery at the closing by the Jones Family Trust of an Unconditional Guaranty by the Jones Family Trust of the \$1,308,000.00 Promissory Note and the liens securing same to be executed by the purchaser at the closing, with said unconditional Guaranty to be in form and substance acceptable to the administration and the District's attorney.

Dr. O'Donnell recommended additional language that approval be pending the presentation of a financial statement for Jones Family Trust prepared by an external firm. Mr. Jack Chapman, Kemp Smith LLP, attorney representing Jones Family Trust, advised that this closely held entity did not have outside audit statements.
