1A. Presentation and Recommendation on International Association of Benefit Plan Proposal

Mr. Eddie Sinegal, representative of International Association of Benefits, provided information on an alternative employee benefit program for employees that do not have health coverage (does not replace District's health plan). Mr. Tafoya recommended that the program be offered to employees through the El Paso Federation of Teachers and Support Personnel or through a direct mailing to employees.

The Committee concurred with the recommendation.

1B. <u>Information on Proportionate Employer Contribution</u>

Administration is continuing to work with District's attorneys on issues related to HIPAA (Health Insurance Portability and Accountability Act). Results/recommendations will be brought back to Board's Employee Health/Insurance Committee.

1C. <u>Final Recommendation on Medically Supervised Weight Loss Program Requirement for Consideration of Bariatric Surgery</u>

Recommendation from Tenet Hospitals Limited to add the completion of a six-month weight loss program to the prerequisites for Bariatric surgery.

1D. <u>Information on Certification of Financial Agents/Representatives for 403(b) Tax Sheltered Annuity Plan</u>

- a. Started with 230 agents.
- b. Provided three training sessions attended by a total of 187 agents.
- c. TRS (Teacher Retirement System) began certifying 403(b) providers in June 2003.
- d. Training to provide certification.
- e. Quarterly sessions throughout the year to get all providers certified.

1E. <u>Possible Discussion of Other Issues Related to Employee Health/Insurance</u>

- a. How 457 Plan is insured.
 - (1) EPISD sponsors plan through Great West to provide services but no insurance.
 - (2) Liability for employee losses covered like an investment.
 - (3) Guaranteed investment covered by Great West.
- b. Discussed study on District participating with Social Security \$18 million for initial cost and annual recurring cost.
- c. Discussed possible claim audit of hospital bills cost to conduct audit approximately \$13,000.00.
