The topics discussed were as follows:

## 1A. <u>Discuss Proposed Revision of EPISD Apprenticeship Program</u>

Mr. Hector Martinez, Associate Superintendent, Operations, and Mr. Nick Corona, Executive Director, Facilities, Maintenance and Construction, provided background information on the EPISD apprenticeship program, which follows the U. S. Department of Labor requirements.

a. City of El Paso reduced its list of apprentice trades and requires approximately 15 identified trades for projects exceeding \$100,000.00.

b. AGC contacted EPISD regarding trimming the District's list of apprentice trades and provided a list of recommended trades for consideration. Administration proposed taking the recommended list to the Board for approval and suggested lowering construction contract costs to \$100,000.00, similar to the City's.

c. Monitoring contractors, enforcing apprenticeship programs, and consequences for noncompliance.

## 1B. <u>Discussion of Prevailing Wage Rates Survey</u>

a. Reviewed law related to prevailing hourly wage rates on public works and EPISD's prevailing wage rates.

- b. Provided comparison of prevailing wage rates among EPISD, other local school districts, and the Davis-Bacon Act.
- c. EPISD rates for 35 classifications and legal counsel recommendation to expand classifications to be more inclusive, as required by the Texas Education Code.
- d. Administration recommended another survey, with the Board to approve conducting the survey.
