

DBD (LOCAL) EMPLOYMENT REQUIREMEN AND RESTRICTIONS: CONFLICT OF INTEREST	ITS Revision	Provisions previously coded at DBF (Local) on Nonschool Employment, which is disappearing altogether from the TASB coding system, has been added to the end of the current DBD (Local) policy.

Other changes have been made for clarity.
