Please call the Policy Office at 887-5813 to receive immediate verification for any online policy that is needed to ensure that the policy has not been recently revised.

The online policies include search capability. By entering key word(s), you can search the entire policy manual at one time and the system pulls up every policy that contains the key word(s).

Our District subscribes to the Texas Association of School Boards' (TASB) policy service *Policy Online (POL)*. There will always be a delay of up to 30 days from the time a policy is approved by the Board until it appears online, but the approved policy can be obtained immediately, if needed, by contacting the Policy Office at 887-5813. Policies online will not have an adopted date printed on them, but you can assume they are correct unless otherwise specified in the notification memos that are sent to you regularly.

Legal policies track the language of the U.S. and Texas Constitutions, federal and state statutes including the Texas Education Code, Texas Attorney General opinions, State Board of Education rules, Texas Administrative Code and other regulations, as well as other sources of legal authority defining local school district governance.

Local policies are generated by our District to support legal requirements and to define the Board's vision for the District, the structure for accomplishing the vision, and the system of accountabilities for all who are involved in realizing the vision. Board policy directs the "footsteps" of students, parents, and staff. It also directs those of the Board itself in responding to emerging issues, clarifying its own roles and responsibilities, defining the decision-making process, and ensuring timely evaluation of programs, personnel, and activities. Local policies are adopted by the Board of Trustees and until rescinded by Board action, have the force of law.

If regulations are present with (LOCAL) policies, they are the action steps that complement the local policy. Exhibits consist of suggested form letters, notices, and reports.

Explanation

This new Board Policy addresses intellectual property, copyright, and trademark. It includes updates to existing local provisions moved from CQ (LOCAL) and EFE (LOCAL) and new provisions on trademark. In moving local policy text under INTELLECTUAL PROPERTY on students and employees from Policy CQ (LOCAL), there are several new provisions. New language at side margin note EMPLOYEE OWNERSHIP clarifies ownership when an employee creates a work on his or her own time with personal equipment and materials. New side margin note PERMISSION states that an employee must obtain special permission to use District materials or equipment for the employee's creative projects. In moving local policy text on copyright from Policy EFE (LOCAL), new language at side margin note COPYRIGHT, explains that an employee or student is responsible for ensuring that a license or permission is obtained before using copyrighted material for instructional, curricular, or extracurricular purposes, unless use of the material is an exception under the "fair use" guidelines maintained by the Superintendent.

The deletion of Board Policy EFE (LOCAL) was recommended since provisions on copyrighted material have been moved to new Board Policy CY (LOCAL), where other relevant provisions on copyright, trademarks, and intellectual property are now located. EFE is no longer an active code.

Explanation

Revisions to this policy were made to include the new provisions in the State of Texas Assessments of Academics Readiness (STAAR) program. New side margin note CERTIFICATE OF COURSEWORK COMPLETION states the District will issue a certificate of completion to any student who has successfully completed state and local credit requirements for graduation, but has failed to meet all applicable state testing requirements. New language under side margin note PARTIAL CREDIT states when a student earns a passing grade in only one semester of a two-semester course and the combined grade for the two semesters is lower than 70, the District shall award the student credit for the semester with the passing grade. Under side margin note FULL CREDIT COURSE GRADE AVERAGING, the averaging method when determining the awarding of credits to a student on a "year-long" course has been changed. New side margin note WITHDRAWAL OR LATE ENROLLMENT states any student, including a migrant or homeless student, who enrolls after the first day of instruction or who withdraws early shall be provided opportunities to achieve mastery of the essential knowledge and skills to meet course requirements.

Grading/Progress Reports to Parents

Explanation

Revisions to this policy were made to include the new provisions in the State of Texas Assessments of Academics Readiness (STAAR) program. New side margin note END-OF-COURSE states when required by State law, a student's initial end-of-course (EOC) assessment shall count for 15 percent of the student's final grade for the course as reported on the student's transcript. Also included is the formula for converting the assessment scores. New side margin note CREDIT states an EOC assessment score shall affect whether a student receives credit for a course as calculated in accordance with the District's grading guidelines. New side margin note RETAKES states EOC retakes will count as 15 percent of the course grade in cases where the student is required to retake the course. EOC scores from retakes will count as 15 percent of the course grade in cases where the course average is at least 70 percent on a hundred point scale, when the original EOC score is not included in the grade.

New side margin note END-OF-COURSE states a student is not required to retake a course if an end-of-course (EOC) assessment score is rated Unsatisfactory Academic Performance, provided the course grade is 70 or above on a 100 point scale.
