| CONFLICTS OF INTEREST | THE IMPLICATION FROM THE APPEARANCE OF A CONFLICT OF INTEREST IS JUST AS IMPORTANT AS THE IMPLICATION FROM AN ACTUAL CONFLICT. IF AN OUTSIDE INDEPENDENT PARTY MIGHT QUESTION THE INTENT OF A TRANSACTION OR RELATIONSHIP, SUCH TRANSACTION OR RELATIONSHIP IS DEEMED TO IMPACT THE APPEARANCE OF A CONFLICT AND THEREFORE SHOULD BE AVOIDED. CIRCUMSTANCES RELATED TO AN APPEARANCE OF CONFLICT INCLUDE THOSE THAT WOULD CAUSE A REASONABLE AND IN- FORMED THIRD PARTY, HAVING KNOWLEDGE OF THE RELE- VANT INFORMATION, TO REASONABLY CONCLUDE THAT A BOARD MEMBER OR EMPLOYEE HAS COMPROMISED OB- JECTIVITY RELATED TO A VENDOR RELATIONSHIP. |

6. BID TAILORING, AS DEFINED BY THE ASSOCIATION OF CERTIFIED FRAUD EXAMINERS, THAT IS INTENDED TO LIMIT COMPETITION OR CREATE AN UNFAIR AD-VANTAGE FOR A SPECIFIC VENDOR.

REPORTING AN INDIVIDUAL WHO DETECTS OR SUSPECTS ANY FRAUD, MISAPPROPRIATION, OR FINANCIAL IMPROPRIETY INVOLV-ING AN EMPLOYEE MUST IMMEDIATELY REPORT THIS TO THE EMPLOYEE'S SUPERVISOR, THE SUPERINTENDENT OR DESIGNEE, THE BOARD PRESIDENT, LOCAL LAW ENFORCE-MENT, OR TO THE DISTRICT'S HOTLINE IN THE DISTRICT'S IN-TERNAL AUDIT OFFICE.

> AN INDIVIDUAL WHO DETECTS OR SUSPECTS ANY FRAUD, MISAPPROPRIATION, OR FINANCIAL IMPROPRIETY OF ANY VENDOR OR POTENTIAL VENDOR, MUST IMMEDIATELY RE-PORT THIS TO THE DISTRICT'S PROCUREMENT SERVICES DEPARTMENT, INTERNAL AUDIT OFFICE, THE SUPERINTEN-DENT OR DESIGNEE, THE BOARD PRESIDENT, LOCAL LAW ENFORCEMENT, OR TO THE DISTRICT'S HOTLINE IN THE DIS-TRICT'S INTERNAL AUDIT OFFICE.

RESTRICTED CONTACT PERIOD PURPOSE – 'CONE OF SILENCE'

RIOD CONE OF SILENCE SHALL APPLY TO THE ACQUISITION OF GOODS OR SERVICES USING THE PROCUREMENT METH-ODS IDENTIFIED IN STATE LAW AS WELL AS RENEWAL PERI-ODS FOR CONTRACTS PREVIOUSLY AWARDED BY THE BOARD WITH RENEWAL OPTIONS.

> "CONE OF SILENCE" SHALL MEAN A PROHIBITION ON ANY COMMUNICATION REGARDING ANY REQUEST FOR INFOR-MATION (RFI), REQUEST FOR QUALIFICATIONS (RFQ), RE-QUEST FOR PROPOSAL (RFP), BID, OR OTHER COMPETITIVE SOLICITATION (AS DEFINED IN THE PROCUREMENT METH-ODS ABOVE) BETWEEN:

- 1. ANY PERSON WHO SEEKS AN AWARD FROM THE DIS-TRICT OR ITS AFFILIATED ENTITIES INCLUDING A PO-TENTIAL VENDOR OR VENDOR'S REPRESENTATIVE; AND
- 2. ANY BOARD MEMBER, SUPERINTENDENT, SENIOR STAFF MEMBER, PRINCIPAL, DEPARTMENT HEAD, DI-RECTOR, MANAGER, OR OTHER DISTRICT EMPLOYEE WHO HAS INFLUENCE IN THE EVALUATION OR SELEC-TION PROCESS.

CAMPAIGN CONTRIBUTIONS, GIFTS, DONATIONS, AND ANY OTHER ITEMS OF VALUE SHALL BE PROHIBITED BETWEEN

THE PARTIES DEFINED ABOVE FOR ANY KNOWN CONTRACT UNDER CONSIDERATION DURING THE CONE OF SILENCE.

EXCEPTION THE CONE OF SILENCE SHALL NOT APPLY TO COMMUNICA-TION WITH THE DISTRICT'S LEGAL SERVICES AND PRO-CUREMENT SERVICES STAFF. SUCH COMMUNICATIONS SHALL BE LIMITED TO THE PURPOSE OF OBTAINING CLARI-FICATION OR INFORMATION CONCERNING THE SUBJECT OF SOLICITATION OR CONDUCTING CONTRACT NEGOTIATIONS.

TIME PERIOD THE CONE OF SILENCE SHALL BEGIN UPON THE DEVELOP-MENT OF THE SCOPE OF WORK THROUGH THE ISSUANCE OF AN RFI, RFP, BID, OR OTHER COMPETITIVE SOLICITATION AS DEFINED IN STATE LAW AND SHALL OFFICIALLY END UPON EXECUTION OF AN AWARD BY THE BOARD AND/OR THE EXECUTION OF A NEGOTIATED CONTRACT, WHICHEVER REPRESENTS THE FINAL ACT IN THE PROCUREMENT PRO-CESS.

> REGARDLESS OF THE ABOVE TIME PERIOD, IT SHALL NOT BE ACCEPTABLE FOR A POTENTIAL VENDOR TO PARTICI-PATE IN DISCUSSIONS THAT DETERMINE THE SCOPE OF WORK, STRATEGIC DIRECTION, TECHNICAL SPECIFICA-TIONS, OR EVALUATION CRITERIA OF SUCH PROJECTS.

> NOTHING CONTAINED IN THIS POLICY SHALL PROHIBIT ANY POTENTIAL VENDOR OR VENDOR'S REPRESENTATIVE FROM:

- 1. MAKING PUBLIC REPRESENTATIONS AT SCHEDULED PRE-BID CONFERENCES OR SCHEDULED SELECTION AND NEGOTIATION COMMITTEE MEETINGS;
- 2. ENGAGING IN CONTRACT NEGOTIATIONS DURING ANY SCHEDULED MEETING;
- 3. MAKING A PUBLIC PRESENTATION TO THE BOARD DUR-ING ANY DULY NOTICED PUBLIC MEETING; OR
- 4. CONDUCTING BUSINESS ON CONTRACTS PREVIOUSLY EXECUTED AND CURRENTLY IN FORCE.

THE POTENTIAL VENDOR OR VENDOR'S REPRESENTATIVE SHALL SEND ALL WRITTEN COMMUNICATION DIRECTLY TO THE DESIGNATED PROCUREMENT STAFF.

NOTHING IN THIS POLICY SHALL PROHIBIT THE PROCURE-MENT STAFF FROM INITIATING CONTACT WITH A POTENTIAL VENDOR OR A VENDOR'S REPRESENTATIVE AND SUBSE-QUENT COMMUNICATION FOR THE PURPOSE OF OBTAINING

CLARIFYING INFORMATION REGARDING A RESPONSE TO AN RFP, BID, OR COMPETITIVE SOLICITATION. SUCH CONTACT, INCLUDING ANY RESPONSE, SHALL BE IN WRITING AND SHALL BE PROVIDED TO THE MEMBERS OF THE APPLICA-BLE PROCUREMENT STAFF.

CONE OF A BOARD MEMBER WHO HAS HAD CONTACT WITH A PERSON SILENCE DISCLOSURES CONE OF SILENCE SHALL DISCLOSE THIS CONTACT TO THE EXECUTIVE DIRECTOR OF PROCUREMENT AND/OR GENERAL COUNSEL.

VIOLATION ANY SUSPECTED VIOLATION OF THE CONE OF SILENCE SHALL BE REPORTED TO THE DISTRICT'S PROCUREMENT SERVICES DEPARTMENT OR THE DISTRICT'S HOTLINE AND MAY RESULT IN THE RECOMMENDATION FOR AWARD, TO THE POTENTIAL VENDOR OR VENDOR'S REPRESENTATIVE, BEING WITHDRAWN OR MAY RESULT IN A VENDOR'S CON-TRACT BEING DEEMED VOID OR VOIDABLE. THE POTENTIAL VENDOR OR VENDOR'S REPRESENTATIVE DETERMINED TO HAVE VIOLATED THIS RULE SHALL BE SUBJECT TO DEBAR-MENT FROM BIDDING AND CONTRACTING ACTIVITIES OF CURRENT AND FUTURE PROJECTS FOR A PERIOD UP TO TWO CALENDAR YEARS (24 MONTHS).

> IN ADDITION TO ANY OTHER PENALTY PROVIDED BY LAW, VI-OLATION OF THIS POLICY BY A DISTRICT EMPLOYEE SHALL SUBJECT THE EMPLOYEE TO DISCIPLINARY ACTION UP TO AND INCLUDING DISMISSAL.

> BOARD MEMBERS WHO HAVE VIOLATED THE RESTRICTED CONTACT PERIOD AND/OR RECEIVED CAMPAIGN CONTRIBU-TIONS, GIFTS, DONATIONS, OR ANY OTHER ITEMS OF VALUE FROM SUCH VENDOR REPRESENTATIVES DURING THE CONE OF SILENCE SHALL ABSTAIN FROM VOTING ON SUCH MAT-TERS RELATED TO THAT VENDOR FOR A PERIOD UP TO TWO CALENDAR YEARS (24 MONTHS).

> IN THE EVENT THAT A BOARD MEMBER OR CANDIDATE UN-KNOWINGLY ACCEPTS A CAMPAIGN CONTRIBUTION, GIFT, DONATION, OR ANY OTHER ITEM OF VALUE FROM A VENDOR REPRESENTATIVE DURING THE CONE OF SILENCE, IT SHALL BE HIS OR HER DUTY TO RETURN THE CONTRIBUTION WITHIN TEN BUSINESS DAYS AFTER BECOMING AWARE OF THE CONFLICT WITH THIS POLICY.

FORMALTHIS POLICY SHALL NOT BE INTENDED TO PROHIBIT CON-
TRACTORS AND THEIR REPRESENTATIVES FROM ISSUING

CONTACT WITH EMPLOYEE / BOARD SALESPERSONS OF EDUCATIONAL PRODUCTS MAY BE PER-MITTED TO MEET WITH EMPLOYEES DURING THEIR PLAN-NING PERIODS OR BEFORE OR AFTER SCHOOL. AN AP-POINTMENT SHALL BE NECESSARY, AND THE VISITATION MUST BE APPROVED BY THE EMPLOYEE AND THE PRINCI-PAL. [SEE ALSO GKC(LOCAL)]

> PERSONS CONDUCTING COMMERCIAL BUSINESS WITH THE DISTRICT SHALL REFRAIN FROM CONTACTING DISTRICT PERSONNEL AND ANY MEMBER OF THE BOARD REGARDING ANY ASPECT OF THE BUSINESS DURING THE CONE OF SI-LENCE DESCRIBED ABOVE.

> COMMUNICATION WITH ANY OF THE BOARD MEMBERS RE-GARDING ANY ASPECT OF THE BUSINESS SHALL BE IN WRIT-ING AND ADDRESSED TO ALL BOARD MEMBERS.

> INDIVIDUAL BOARD MEMBERS WHO ARE CONTACTED BY PERSONS CONDUCTING BUSINESS OR SEEKING TO CON-DUCT BUSINESS WITH THE DISTRICT SHALL REFER SUCH PERSONS TO THE OFFICE OF THE SUPERINTENDENT FOR ADMINISTRATIVE RESPONSE.

"CONDUCTING BUSINESS" SHALL INCLUDE PARTICIPATION IN A PENDING PROCUREMENT, THE NEGOTIATION OF ANY CONTRACT, THE PERFORMANCE OF ANY CONTRACT, THE SELLING OF ANY PRODUCT, AND THE PERFORMANCE OF ANY SERVICE.

BOARD MEMBER CONTACT WITH VENDORS BOARD MEMBERS SHALL NOT KNOWINGLY CONTACT PER-SONS DOING BUSINESS OR SEEKING TO DO BUSINESS WITH THE DISTRICT DURING THE CONE OF SILENCE AS DE-SCRIBED ABOVE.

VENDOR DATA REQUIREMENTS EVERY INDIVIDUAL OR ENTITY WHO CONTRACTS OR SEEKS TO CONTRACT WITH THE DISTRICT FOR THE SALE OR PUR-CHASE OF PROPERTY, GOODS, OR SERVICES SHALL FILE A COMPLETED CONFLICT OF INTEREST QUESTIONNAIRE AT THE TIME OF RESPONDING TO AN RFP, RFQ, BID OR RE-QUEST FOR A QUOTE. IF A CONSULTANT OR VOLUNTEER PARTICIPATES IN THE EVALUATION OF A RFP, RFQ, OR BID, A COMPLETED CONFLICT OF INTEREST QUESTIONNAIRE MUST BE COMPLETED AND SUBMITTED TO THE PROCURE-MENT DEPARTMENT.

EVERY ENTITY THAT CONTRACTS OR SEEKS TO CONTRACT WITH THE DISTRICT FOR THE SALE OR PURCHASE OF PROP-ERTY, GOODS, OR SERVICES SHALL ALSO FILE A COM-PLETED FORM 1295, PURSUANT TO STATE LAW AT THE TIME OF RESPONDING TO AN RFP, RFQ, BID, OR REQUEST FOR A QUOTE. PRIOR TO ANY AWARD OR RECOMMENDATION, THE DISTRICT WILL REVIEW THE INFORMATION PROVIDED AND MAKE A RECOMMENDATION TO THE BOARD.

THE BOARD MAY USE THE INFORMATION TO DETERMINE WHETHER ANY POTENTIAL CONFLICTS EXIST AND TO DE-TERMINE WHETHER SUCH CONFLICTS OF INTERESTS ARE OF SUFFICIENT MAGNITUDE AS TO WARRANT:

- 1. DISQUALIFICATION OF A BOARD MEMBER, DISTRICT EMPLOYEE, CONSULTANT OR VOLUNTEER FROM PAR-TICIPATION IN ANY DECISION PERTAINING TO CONDUCT-ING BUSINESS WITH SUCH A COMPANY.
- 2. DISQUALIFICATION OF THE COMPANY OR CORPORA-TION FROM CONDUCTING BUSINESS WITH THE DIS-TRICT.

IF ANY COMPANY, CORPORATION, ORGANIZATION, OR INDI-VIDUAL REFUSE OR WILLFULLY FAIL TO PROVIDE THE RE-QUESTED DATA WITHOUT CONSENT OF THE BOARD, THE BOARD MAY CONSIDER SUCH REFUSAL OR FAILURE AS GOOD CAUSE TO NOT CONDUCT BUSINESS WITH SUCH COMPANY, CORPORATION, ORGANIZATION, OR INDIVIDUAL FOR NO LESS THAN TWO YEARS.
