- MEAL CHARGES STATE LAW AS ESTABLISHED BY THE BOARD, A STUDENT WITH AN EX-HAUSTED OR INSUFFICIENT BALANCE ON HIS OR HER MEAL CARD OR MEAL ACCOUNT SHALL BE ALLOWED TO CON-TINUE TO PURCHASE MEALS FOR UP TO THREE MEALS FOR A STUDENT IN ELEMENTARY OR MIDDLE SCHOOL AND ONE MEAL FOR A STUDENT IN HIGH SCHOOL. THE SUPERINTEN-DENT SHALL DEVELOP ADMINISTRATIVE REGULATIONS FOR THIS GRACE PERIOD TO ADDRESS:
 - 1. THE DISTRICT'S PROCESSES FOR PARENT NOTIFICA-TION DURING THE GRACE PERIOD, INCLUDING A SCHEDULE FOR REPAYMENT; AND
 - 2. WHETHER THE STUDENT WILL BE LIMITED TO CERTAIN FOODS OR BEVERAGES DURING THIS GRACE PERIOD, AND, IF SO, THE DISTRICT'S EFFORTS TO MINIMIZE OVERT IDENTIFICATION OF THE STUDENT.

NO FEES OR INTEREST SHALL BE CHARGED BY THE DIS-TRICT FOR MEALS PURCHASED DURING THE GRACE PE-RIOD.

- FEDERAL LAW FOR EACH CAMPUS THAT PARTICIPATES IN THE FEDERAL SCHOOL BREAKFAST OR LUNCH PROGRAMS UNDER WHICH STUDENTS MAY INCUR A MEAL CHARGE, THE DISTRICT'S AD-MINISTRATIVE REGULATIONS SHALL ALSO ADDRESS PRO-CEDURES FOR A STUDENT WHO HAS INSUFFICIENT FUNDS TO PURCHASE A MEAL FOLLOWING EXHAUSTION OF THE GRACE PERIOD DESCRIBED ABOVE. THE PROCEDURES SHALL ADDRESS:
 - 1. THE PARAMETERS UNDER WHICH REIMBURSABLE OR ALTERNATE MEALS SHALL BE SERVED TO THE STU-DENT;
 - 2. THE DISTRICT'S EFFORTS TO MINIMIZE OVERT IDENTIFI-CATION OF THE STUDENT; AND
 - 3. HOW THE DISTRICT WILL ATTEMPT TO COLLECT UNPAID DEBT IN ORDER TO MAINTAIN THE FINANCIAL INTEG-RITY OF THE FOOD SERVICE ACCOUNT.

THE SUPERINTENDENT SHALL DEVELOP REGULATIONS RE-GARDING THE USE OF A PREPAID MEAL CARD OR ACCOUNT TO PURCHASE MEALS SERVED AT SCHOOL. THE REGULA-TIONS SHALL ADDRESS:

- 1. THE LENGTH OF THE GRACE PERIOD DURING WHICH A STUDENT MAY CONTINUE TO PURCHASE MEALS WITH A MEAL CARD OR ACCOUNT THAT IS EXHAUSTED OR IN-SUFFICIENT; AND
- 2. PARENT NOTIFICATION IN THE EVENT OF AN EX-HAUSTED CARD OR ACCOUNT, INCLUDING A SCHEDULE FOR REPAYMENT.

NO FEES OR INTEREST SHALL BE CHARGED IN CONNECTION WITH MEALS PURCHASED WITH AN EXHAUSTED CARD OR ACCOUNT.
