### **Major Responsibilities and Duties**

### Vehicle Operation

- 1. Transport up to 77 students following assigned route and adheres to established schedules.
- 2. Drive bus to and from extracurricular activities.
- 3. Perform a thorough pre-trip and post-trip inspection of school bus.
- 4. Report accidents, vehicle damage, student injuries, and mechanical failures; completes required reports.
- 5. Keep records of bus mileage and number of passengers transported.
- 6. Keep assigned bus clean and fueled.
- 7. Operate two-way radio equipment to communicate with transportation office.
- 8. Attend and complete training program to maintain safety certification.
- 9. Maintain monthly student ridership reports.

### **Student Management**

- 10. Supervise students while loading and unloading at all pick up and drop off points.
- 11. Load and unload students at authorized locations only.
- 12. Communicate with teachers and parents daily regarding student behavior while on the bus.
- 13. Maintain discipline and reports student discipline problems to campus administration.
- 14. Ensure students are aware of rules and responsibilities as passengers.

### Safety

- 15. Observe traffic laws and safety regulations for school buses.
- 16. Inspect the bus by checking fuel, oil, water, tires, lights, brakes, and steering to ensure the bus can be operated safely before driving.
- 17. Ensure proper condition of emergency equipment, such as first aid kit, fire extinguisher, flags, fuses, crowbar, and reflectors.

- 18. Report any hazardous conditions along the route.
- 19. Follow established safety procedures and techniques to perform job duties, including lifting, and climbing.
- 20. Correct unsafe conditions in the area supervisor immediately.
- 21. Inspect the school bus at the end of each run and ensure no students or objects are left behind in the bus.
- 22. Perform other duties as assigned by supervisor.
