3. Verify that pianos are in optimal condition.
4. Submit requests for the transfer of any pianos that are transported to or from a school or the Fine Arts Music Repair Shop.
5. Relocate pianos as needed.
6. Record and verify repairs and modifications.
7. Overhaul and refinish pianos.
8. Repair and tune electronic piano labs and pianos.
9. Repair school pianos by regulating action, pedals, and dampers, leveling keys, replacing strings, pins, felts, screws, hammers, shanks, punching, flangers, voicing, and jacks
10. Locate and prepare pianos for contests and concerts.
11. Assist with the inventory of musical instruments and supplies.
12. Perform other duties as assigned by supervisor.
