4. Monitor network equipment via management applications and tools.
5. Work with technical staff and users on reported network issues and determine resolution.
6. Identify and resolve network-related hardware and software problems.

7. Analyze and monitor network performance concerns, provide recommendations to the IT Operations Manager for improvement of network systems.
8. Lead the implementation and routine maintenance of network-related hardware and software.
9. Install, maintain, and operate servers (physical and virtual) used for network operations; integrate with District Active Directory.
10. Install, maintain, and operate District Infoblox DHCP/DNS appliances.
11. Install, maintain, and operate the District Palo Alto Firewall.
12. Work with vendors to carry out statements of work and ensuring completion of projects per District specifications.
13. Assist network and other technical staff to ensure efficient operation and resolve network and application related problems.
14. Utilize system and security tools to secure networks and associated equipment.
15. Perform other duties as assigned by supervisor.
