# Major Responsibilities and Duties

## **Instructional and Program Management**

- Per SB179, spend 80% of their counseling duties on a comprehensive school counseling program:

   a guidance curriculum (instruction) to help students develop their full educational potential, including the student's interests and career objectives;
   a responsive services (counseling) component to intervene on behalf of any student whose immediate personal concerns or problems put the student's continued educational, career, personal, or social development at risk;
   an individual planning system (appraisal and advisement) to guide a student as the student plans, monitors, and manages the student's own educational, career, personal, and social development; and
   system support (indirect student services: consultation, collaboration, referrals) to support the efforts of teachers, staff, parents, and other members of the community in promoting the educational, career, personal, and social development of students.
- 2. Per SB179, time spent in administering assessment instruments or providing other assistance in connection with assessment instruments, except time spent in interpreting data from assessment instruments, is not considered time spent on counseling.
- 3. Per SB179, document and report counselor use of time to comply with the SB179 annual District assessment requirement.
- 4. Track and document their time on Fair-Share duties.
- 5. Provide and document individual and group counseling to address academic, career, and personal/social/emotional needs through District approved platforms, e.g., College and Career Readiness Planner (CCRP).
- 6. Promote District's initiatives and a growth mindset when working with staff, parents, community, and students.
- 7. Assist students in interpreting required state test scores as well as: TELPAS, CBE., End of Course Exams, PSAT, TSI and other standardized tests scores.
- 8. Assist students and parents with career exploration and planning.

- 9. Assist in identifying students with special needs and make proper referrals for services.
- 10. Assist students with the transition from elementary to middle and from middle to high school.
- 11. Assist students and parents with developing a high school four-year plan for every eighth-grade student and identifying a HB5 Endorsement and Program of Study (POS).
- 12. Review students' course selection for correct placement in courses and programs in the College and Career Readiness Plan (CCRP) and the Academic Achievement Record (AAR).
- 13. Review student's academic record to identification of course selection for correct placement in courses and programs, etc. related to grade level appropriate state accountability standards to include College, Career, and Military Readiness (CCMR).
- 14. Participate in ARD's and Section 504 meetings as needed.
- 15. Assist students and parent with college admission information to include scholarships, grants, Free Application for Federal Student Aid (FAFSA) middle school course offerings, high school course offerings, Program of Study (POS), high school graduation plans, magnet school information, early college high school, Dual Credit, and advanced courses (AP, Pre-AP, IB, and IB Prep), Career and Technical Education (CTE).
- 16. Submit reports as requested by the Director, Counseling and Advising.

## School/Organizational Climate

- 17. Communicate and promote high expectations for student performance and behavior while communicating effectively with students, parents, staff, and community.
- 18. Participate in establishing and maintaining a positive school climate.
- 19. Foster collegiality and team building among staff.
- 20. Plan and align collaboratively with elementary and high school counselors regarding the transition to middle school from elementary and from middle school to high school to meet academic student needs.
- 21. Contribute and support colleagues in accomplishing the school's mission.
- 22. Develop, promote, and support a campus-wide culture focused on District student learning goals, with an emphasis on trust, respect and responsibility for students, parents, teachers, and staff.

### **School/Organizational Improvement**

- 23. Identify, analyze, and apply research findings to facilitate the delivery of a comprehensive developmental counseling and guidance program.
- 24. Develop, maintain, and utilize appropriate TEAMS information systems and records necessary (transcripts, cum folders, College and Career Readiness Planner (CCRP) and Program of Study (POS) for attainment of district graduation goals.

- 31. Attend ARD and Section 504 meetings for caseload, as needed
- 32. Present and document classroom guidance lessons for all grade levels 6<sup>th</sup> through 8<sup>th</sup> related to academic, personal, and social/emotional issues, e.g., character education and teen dating violence, etc.
- 33. Plan and align collaboratively with elementary and high school counselors regarding the transition from elementary to middle school and from middle to high school to meet the academic, emotional, and social needs of students.

- 34. Provide faculty, staff, and students training on recognizing the signs of emotional abuse, physical abuse, and sexual abuse; suicidal ideation; harassment/bullying; and teen dating violence, as well as the requirements for reporting the abuse to the appropriate authorities.
- 35. Follow district policy for placing students in the correct grade level.
- 36. Maintain and submit student management services reports as requested by the Director, Counseling and Advising.

# School/Community Relations

- 37. Demonstrate awareness of school/community needs and initiate activities to meet those needs.
- 38. Provide parents with information about school policies and procedures, middle school course offerings, high school offerings, Program of Study (POS), high school graduation plans, magnet school information, early college high school, Dual Credit, advanced courses (AP, Pre-AP, IB, and IB Prep), and Career and Technical Education (CTE).
- 39. Provide information to parents about students' academic records and progress.
- 40. Inform parents about guidance services available.
- 41. Coordinate visits for representatives of agencies, businesses, and other community resources.
- 42. Project a positive image to the community.
- 43. Provide quality customer service and professional behavior when working with staff, parents, community, and students.
- 44. Maintain ongoing communication with Principal, Lead Counselors, and Director, Counseling and Advising.
