Primary Purpose

Administer and support the district's enterprise infrastructure systems to ensure the secure, reliable, and high-performing operation of all cores, distribution, and edge infrastructure services. Configure, monitor, and maintain infrastructure hardware and software supporting wide area network (WAN), local area networks (LAN), wireless, and security operations across all district sites. Support ongoing operations, troubleshooting, documentation, and collaboration in technology initiatives that enhance district connectivity, security, and instructional capability.

Major Responsibilities and Duties Infrastructure Administration and Support

- 1. Administer, install, and maintain the district's enterprise infrastructure including switches, routers, firewalls, and wireless controllers.
- 2. Ensure high availability and performance of LAN/WAN networks and wireless environments across all campuses and administrative sites.
- 3. Maintain daily operations and integrity of infrastructure systems across core, distribution, and edge network layers.

Infrastructure Configuration, Operations and Maintenance

- 4. Apply IOS updates, patches, and configuration changes in accordance with district policies and change control procedures.
- 5. Troubleshoot hardware and software issues related to infrastructure and escalate complex issues as needed
- 6. Administer and support activities within Network and Data Operations Centers (NOCs) to ensure continuity of services.
- 7. Monitor systems proactively and respond to outages and incidents affecting district operations.
- 8. Works with cabling and distribution infrastructure plant systems, and installation, cable structure certifications.
- 9. Maintain accurate device configurations and ensure compliance with infrastructure standards.

Infrastructure Security and Compliance

- 10. Implement and support infrastructure security measures, including ACLs(spell out), VLAN segmentation, firewall rules, and intrusion prevention systems.
- 11. Assist in the response to infrastructure-related security incidents and vulnerabilities.
- 12. Ensure all systems comply with district cybersecurity policies and legal regulations.
- 13. Follows incident and change management protocols, documentation, and reporting.
- 14. Support the implementation of backup, recovery, and failover plans for critical infrastructure services.
- 15. Assist with disaster recovery testing and infrastructure continuity planning.

Troubleshooting and Technical Support

- 16. Serve as Tier 2/Tier 3 escalation for infrastructure-related incidents and service requests.
- 17. Diagnose and resolve issues related to connectivity, bandwidth, latency, and device performance.
- 18. Collaborate with Help Desk staff and system engineers to ensure timely issue resolution and user support.

Documentation and Inventory Management

19. Maintain current network diagrams, infrastructure and distribution frame plant systems documentation, device configurations, inventory records, VLANs, IP Schemas and standard operating procedures.

Project Collaboration and Support

- 20. Participate in the deployment and integration of new infrastructure projects, upgrades, and network expansions.
- 21. Collaborate with engineers, vendors, and cross-department teams to support infrastructure initiatives and capital improvement efforts.
- 22. Contribute to planning and testing efforts for system changes, ensuring minimal disruption to district operations.

Professional Development and Innovation

- 23. Stay current on infrastructure technologies, tools, and best practices through research, training, and certifications.
- 24. Attend professional & leadership growth opportunities and maintain a broad and current knowledge of emerging technology, innovation, equipment, and systems.
- 25. Identify opportunities for process and performance improvements within the district's infrastructure



environment.

26. Recommend enhancements to increase system reliability, scalability, and security.
